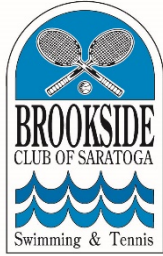

The Brookside Club of Saratoga is a private member-owned, family-oriented swim and tennis club nestled among the trees of a quiet residential Saratoga neighborhood. Active swim and tennis programs for adults and children create an outstanding environment for the entire family. As a member-owned club, Brookside offers many advantages in addition to its numerous sports programs, social events, and facilities.

Membership is limited to 250 families. Memberships can be purchased for a onetime fee and sold at a future time. Members own and operate the club, serving on the Board of Directors and the various committees putting control directly into the hands of the members. Brookside is a financially sound, professionally managed club that has been successfully operating for over 50 years.

Here are some answers to common questions.

- We currently have several memberships up for sale.
- Our memberships are for the entire club which includes swimming and tennis. There are no special memberships just for only swimming or only tennis.
- A membership covers the entire family living at the house. There are some exceptions to this for older children (25+) that might still be living at home.
- The price is set by the club and is currently \$5,000. This price is subject to change based on market value at the time of sale. Members can also sell their membership themselves at a price of their choosing (minimum \$1500 to cover their transfer fee).
- We charge monthly membership dues with the current price of \$173.00.
- Special events, tennis lessons, swim lessons, and other activities have additional fees.
- There is a swim team for the youth of the club. Only members can be on the swim team. The season is April through July.
- Our club is mainly a daylight club with the clubhouse and tennis courts opening at 8:00am and closing just after sunset. The pool opens for adults at 6:30am Monday through Friday, and 8:00am for all ages Monday through Friday. The pool is opened for all ages at 9:00am on Saturdays, and 10:00am on Sundays.
- The pool is heated at 82 degrees and is open all year round

If you would like, I would be more than happy to show you around and explain more about the club. I am available by appointment Tuesday through Saturday from 9:00am to 5:00pm.
